

# CNATRA TRAINING SYSTEMS CHECK-IN SHEET

**PRIVACY ACT STATEMENT**

ROUTINE USES: In addition to those disclosures generally permitted under 5 U.S.C. §552a(b) of the Privacy Act, information within CNATRA Training Systems may be shared within the Navy, Marine Corps, and other DoD components with a demonstrated need to know, with other Federal agencies for authorized purposes (e.g., USCG, NASA, FAA, NTSB), and to educational institutions upon requests for academic transcripts.

DISCLOSURE: Disclosure is voluntary; however, failure to provide the information may result in disenrollment from flight training.
