Subj: MODIFIED UNDERGRADUATE MILITARY FLIGHT OFFICER (MOD UMFO)  
PIPELINE FLOW PROGRESSION

1. Purpose. To promulgate Student Naval Flight Officer (SNFO) pipeline syllabus execution guidance until the Multi-Crew Simulator (MCS) is ready for student training and the first student is enrolled in the Advanced Maritime Command and Control Undergraduate Military Flight Officer (UMFO) Training System (CNATRANOTE 1542.171). While the MCS is still in development, the current expected ready for student training date is October 2014.

2. Syllabus. All SNFOs shall enroll in Primary 1 and subsequently Primary 2 as described in reference (a). Upon completion of Primary 2, students shall be selected for the Intermediate, Maritime, or TACAMO pipelines. All students selected for the following pipelines will proceed as follows:

a. SNFOs selected for the Intermediate pipeline will remain in VT-10 and enroll in the Intermediate UMFO Training System, reference (b). Upon completion, students will be selected for the E-2 or Strike Fighter pipelines.

(1) SNFOs selected for Advanced Strike Fighter will proceed to VT-86 for Advanced Strike Fighter UMFO Training System, reference (c) and designation as a Naval Flight Officer.

(2) SNFOs selected for the E-2 pipeline will complete a bridge syllabus and then transfer to VAW-120 for the Advanced portion of training and designation as a Naval Flight Officer. SNFOs are not expected to be selected for the E-2 pipeline until March 2015.

b. SNFOs selected for the Maritime or TACAMO pipelines will transfer to VP-30 or VQ-7 respectively for the Advanced portion of training and designation as a Naval Flight Officer.
