SUBJ: MISSION ESSENTIAL AND RECOVERY PERSONNEL ASSIGNMENT

Ref: (a) CNASTAFFINST 3440.1C

1. Purpose. Pursuant to reference (a), this notice identifies Chief of Naval Air Training (CNATRA) Mission Essential and Recovery Personnel. Recovery Personnel listed below have been identified to the Naval Air Station Corpus Christi (NASCC) Emergency Management Officer. If issued NASCC Identification Cards, personnel will be required to show these cards to security personnel to access NASCC during emergency conditions.

2. Mission Essential Personnel.
