1. Purpose. To clarify and reiterate the applicable requirements regarding subject report.

2. Discussion

a. Reference (a) and (b) require officers exercising general court-martial jurisdiction (OEGCMJ) to submit subject report to the Office of the Judge Advocate General on a quarterly basis. Reference (a) and (b) further requires that all officers exercising summary or special court-martial jurisdiction submit feeder reports to the cognizant OEGCMJ.


b. Reference (c) provides that Chief of Naval Air Training (CNATRA), as Regional Area Coordinator, is the OEGCMJ for all Navy commands in Texas, Arizona, New Mexico, Colorado, Utah, Idaho, Montana, and Wyoming, in the absence of specific direction to the contrary by a general court-martial convening authority superior in the chain of command to the commanding officer of a command within the region.

3. Action. All commands for whom CNATRA is the OEGCMJ are reminded to ensure timely compliance with the reporting requirements of reference (a) by filing enclosure (1) with CNATRA (Code 01C) no later than the 15th day of the month immediately following each calendar year quarter (January, April, July, October). Negative reports are required.
