I FULLY UNDERSTAND THAT PERSONAL PROTECTIVE EQUIPMENT (PPE) IS MANDATORY PER OPNAVINST 5100.12H AND MUST BE WORN WHILE OPERATING OR RIDING ON A MOTORCYCLE REGARDLESS OF LOCATION OR DUTY STATUS. MANDATORY PPE REQUIREMENTS ARE: A PROPERLY FASTENED PROTECTIVE HELMET **THAT MEETS U.S. DEPARTMENT OF TRANSPORTATION (DoT) STANDARD**; PROTECTIVE EYE DEVICES DESIGNED FOR MOTORCYCLE OPERATORS (IMPACT OR SHATTER RESISTANT SAFETY GLASSES, GOGGLES, WRAP AROUND GLASSES OR FACE SHIELD PROPERLY ATTACHED TO THE HELMET); STURDY OVER THE ANKLE FOOTWEAR; LONG-SLEEVED SHIRT OR JACKET, LONG LEGGED TROUSERS; FULL FINGERED GLOVES OR MITTENS DESIGNED FOR USE ON A MOTORCYCLE; REFLECTIVE OUTER GARMENTS OR VEST AT NIGHT. THE FOLLOWING PPE IS RECOMMENDED FOR USE: BRIGHTLY COLORED OUTER GARMENTS DURING THE DAY; GARMENTS CONSTRUCTED OF ABRASION RESISTANT MATERIALS SUCH AS LEATHER, KEVLAR, AND/OR CORDURA; GARMENTS CONTAINING IMPACT ABSORBING PADDING.

I UNDERSTAND THAT I AM REQUIRED BY OPNAVINST 5100.12H TO ATTEND INITIAL (BASIC RIDERS COURSE (BRC)) AND REFRESHER MOTORCYCLE OPERATOR TRAINING. THIS TRAINING IS AVAILABLE AT NO COST. EVERY MILITARY OPERATOR OF A MOTORCYCLE, WHETHER ON OR OFF INSTALLATION MUST SUCCESSFULLY COMPLETE APPROVED MOTORCYCLE TRAINING PRIOR TO OPERATING A MOTORCYCLE. SPORT RIDERS SHALL COMPLETE THE MILITARY SPORT RIDERS COURSE (MSRC) WITHIN 60 DAYS OF COMPLETION OF THE BRC OR PURCHASE OF A SPORT BIKE. REFRESHER TRAINING (EXPERIENCED RIDER COURSE (ERC) FOR CRUISER RIDERS; MSRC FOR SPORT RIDERS) IS REQUIRED EVERY 3 YEARS.

I UNDERSTAND I AM REQUIRED TO TURN IN ANY DOCUMENTATION OF APPROVED MOTORCYCLE TRAINING TO MY CHAIN OF COMMAND AND **OR GROUND SAFETY OFFICER.**

I FULLY UNDERSTAND THAT OPERATING A MOTORCYCLE IS A PERSONAL CHOICE AND I AM PERSONALLY ACCOUNTABLE FOR MY ACTIONS, SUCH AS RECKLESS DRIVING OR THE ABSENCE OF PPE. I UNDERSTAND THAT OPNAVINST 5100.12H IS A LAWFUL GENERAL ORDER AND VIOLATIONS OF IT ARE SUBJECT TO POTENTIAL DISCIPLINARY ACTION UNDER ARTICLE 92 OF THE UCMJ. ADDITIONALLY, VIOLATIONS OF OPNAVINST 5100.12H MAY BE CONSIDERED IN MAKING LINE OF DUTY/MISCONDUCT DETERMINATIONS FOR INJURIES RECEIVED ON OR OFF BASE.
